Landscaping and Paver Patio: install new paver patio (~16-1/2 feet deep) adjacent to rear of house; mahoe tree on west side of paver patio; clumping bamboo between existing rear planting beds; tree stump and plants to be removed from southwest planting bed, replaced with 3 Bougainvillea trees, fountain grass, dwarf Carissa, periwinkle vinca; add one row of red bricks along west side of driveway; add stones to all planting beds.
