NEW BUSINESS

SPECIAL ASSESSMENT

Pursuant to our CC&Rs, and in accordance with its fiduciary duty to the Association, the Board has determined that it is necessary to levy a Special Assessment against the Membership, the purpose of which is to recoup the funds spent for common area clean-up, repairs, construction and other expenses as a result of Hurricane Ian in September 2022.

As this was a Membership vote, owners indicated their preference (in favor or opposed) on printed forms bearing their signature. Susie Bianchi (CAM) collected and affirmed that 31 valid votes were received. With 27 votes in favor, and 4 votes opposed, the Membership approved the Special Assessment of \$1000 per Lot.

Members were advised that collection of the assessments will begin October 1, 2023. Payments can be made in 1) a lump sum of \$1000, or 2) four quarterly payments of \$250 each. Tropical Isles will send payment details and coupons to each household. In addition, they will prepare a declaration letter that can be submitted to a homeowners' insurance company for reimbursement as a separate loss assessment claim.

ADJOURNMENT

Motion to adjourn the meeting. Motion was made by Larry Ferris, seconded by Susan Dyszel, with all voting in favor to adjourn the meeting at 6:09pm.
