It was strongly suggested that the Association hire an attorney to oversee this endeavor, so that any amendments are in full compliance with all applicable laws and statutes. The Board was also advised that the attorney can perform a basic "pass/fail" approach regarding Developer-related language.

The Board determined that an ad hoc committee should be convened to oversee the direction of this project. Some of the tasks assigned to this committee would include: a thorough review and understanding of all documents, creating a list of items to address or revise, holding meetings as needed to discuss topics and reporting progress to the Board.

To help with the document review and edit process, Mark Rudland stated that he will provide an editable version of the CC&Rs to the Board.

The next Board of Directors meeting is scheduled for Sunday, April 23 at 4:00 pm at the Pavilion.
