# PROOF OF NOTICE OF MEETING:

Notice was posted on April 27, 2019 at the Pavilion signboard and emailed to all Homeowners and posted on CelebrationCape.org in accordance with Florida Statutes, Chapter 720 and the Association By-Laws.

#### **PRIOR MINUTES:**

The minutes from the March 17, 2019 Board of Directors meeting were reviewed and approved. Jim Arnold made the motion to approve, Seconded by Susan Dyszel. A copy of the March 17, 2019 minutes will be posted on CelebrationCape.org

### **NEW BUSINESS:**

Motion to approve expenditure of funds to replace 2 palm trees in the front entryway.
 Motion made by Jim Arnold, Seconded by Art Haase

Vote: Motion carried with 5 votes

2. Motion to approve Annual Reminder of Homeowners Responsibilities.

Motion was made by Susan Dyszel, Seconded by Jim Arnold

Discussion: A copy is to be sent to and distributed by Tropical Isles Management.

Vote: Motion carried with 5 votes

3. Motion to provide information regarding the ownership of the drainage ditch beyond the south wall to Tropical Isles.

Motion was made by Jim Arnold, Seconded by Art Haase

Discussion: Provide information to Tropical Isles. Art Haase is authorized to review information with Tropical Isles. Mark Rudland will review information with an attorney. Information will be presented to The City of Cape Coral. This is to be completed before our deadline of May 28<sup>th</sup> 2019. The Board will receive copies of all that transpires.

Vote: Motion carried with 5 votes

4. Motion to send an ARM request to install a fence for #252 back to the homeowner for resubmission to the ARB.

Motion was made by Jim Arnold and died for lack of a second.

Discussion: New residents installed a temporary fence while waiting for approval of their ARM.

The ARB requested that the Board make a decision.

Vote: No vote

5. Motion to accept the installation of the fence at #252.

Motion was made by Susan Dyszel and seconded by Jim Petrick.

Discussion: Reviewed a complete copy of the ARM to determine if the originally intended fence would fall within neighborhood guidelines.

Vote: Motion carried with 4 votes

6. Motion was made to fine the homeowners of #252 for noncompliance regarding the installation of an entryway enclosure without submitting an ARM, but to allow the enclosure to remain. Motion was made by Jim Arnold and seconded by Art Haase.

Discussion: The process requires a homeowner to receive a letter informing them of the noncompliance. They will be invited to attend a meeting regarding the matter, but are not required to attend.

Vote: Motion carried with 5 votes

7. Discussion regarding the condition of the pond was touched upon but will be tabled until the next meeting.

1. A request to discuss the idea of neighborhood Century Link will be tabled until the next meeting.
